Declared Risk Articles

In New Zealand, manufacturers or imports of electrical products are responsible for ensuring product safety before they are offered for sale. Supplied electrical appliances and fittings must comply with recognised safety standards as of *Electricity (Safety)* Regulations 2010.

Under the *Regulation 84 to 86A of Electricity (Safety) Regulations 2010*, Declared High Risk Articles must hold Supplier Declaration of Conformity (SDoC) in addition to Approval Certificate from WorkSafe or by a recongised body before the product is sold. *Note: Declared High Risk Articles in New Zealand are also Level 3 in-scope equipment in Australia.

Under the *Regulation 83 & 83A of Electricity (Safety) Regulations 2010*, Declared Medium Risk Articles must hold Supplier Declaration of Conformity (SDoC) before the product is sold.
